The **Forensic Interview** is a child's starting point in the healing journey. A highly trained CAC Forensic Interviewer gathers the child's story after there has been an allegation of sexual or physical abuse or the child has witnessed violence. The interview is legally sound, child-focused and designed to limit additional trauma. It is also used by the Multidisciplinary Team to decide next steps in the legal case.

healing

A CAC **Advocate** continues the journey with the family, helping them navigate the legal system and connect with other support services.

resiliency

CAC **Therapists** join the child and (non-offending) family members on the healing journey, providing individual, parent-child, group and specialized therapy.

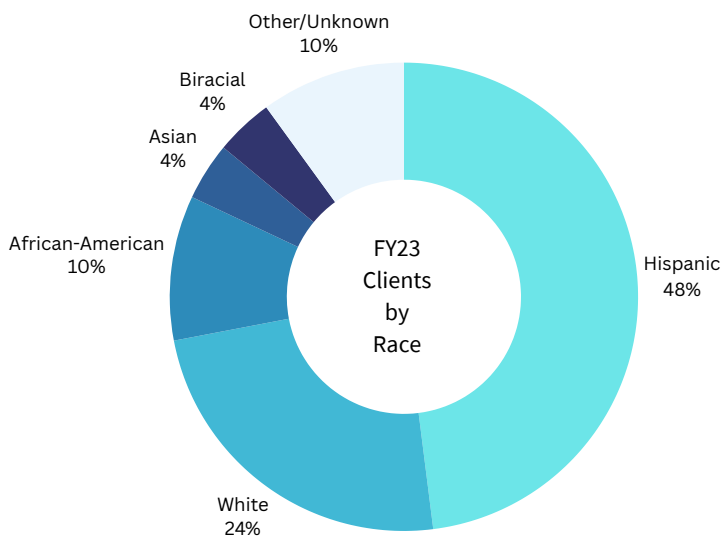
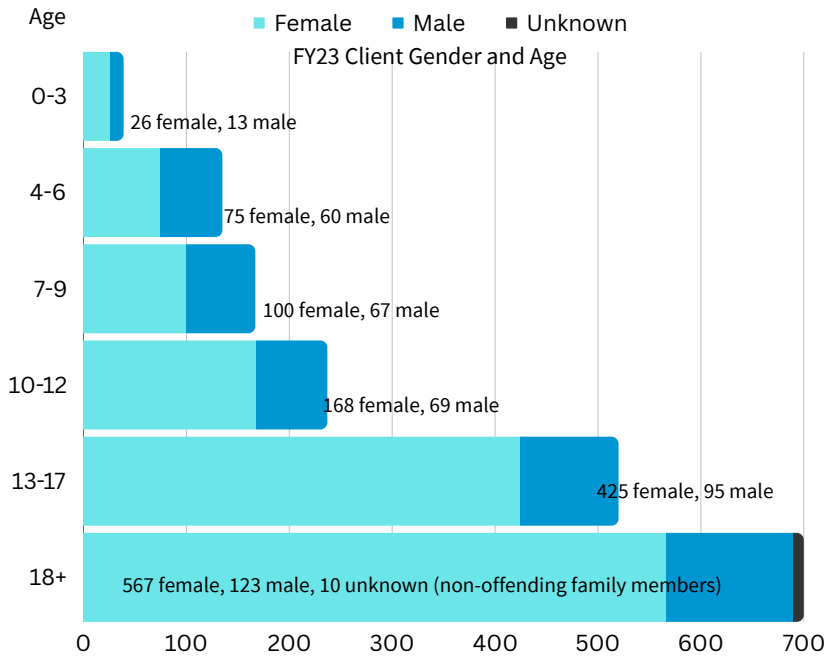

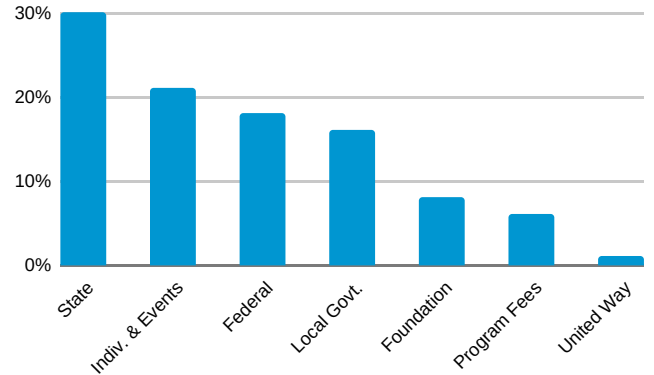

FAQS

How do people find out about CAC?

Once an allegation of abuse has been made by a child, most calls to CAC are initiated by either a local law enforcement agency or the Department of Children and Family Services (DCFS). From there, CAC's Multidisciplinary Team Coordinator compiles the specifics of the case before the family and team of investigators are brought to the CAC. In addition, CAC's Mental Health Services clients come from a variety of outside referral sources.

What if a child or caregiver doesn't speak English?

All of our services are offered in both English and Spanish. CAC is also connected with an interpreter bank to provide other language translation as needed.

What does it cost to use CAC's services?

Our clients pay absolutely nothing. CAC is funded through public and private grants, special event revenue and individual gifts.
